Rationale: An ordained minister is a person authorized by a church, Christian denomination, or other religious body, to conduct various liturgical operations (i.e., baptism, wedding, Lord's Supper, Foot washing, and funerals). He/ She might provide spiritual guidance, preach, and teach Bible-rooted instruction. Ordination can progress along a traditional or a nontraditional path. The path is determined by the prospective ordinand's reasons, timing, financial factors, and ordaining entity.
